
Academic Statistics

Academic preparation is the primary factor in Columbia's holistic review. Students' performance in their secondary school coursework is one indication of readiness, demonstrating the knowledge they have gained and the skills they have developed. Successful applications show strong academic performance across subjects, and from schools that reported rank, 94% of enrolling students were in the top 10% of their graduating class.

Columbia is test-optional, and the score range for the middle 50% of enrolling students who chose to submit scores was 1510-1560 on the SAT and 34-36 on the ACT. Students who opt not to submit test scores will not be at a disadvantage in our process.

ACADEMIC AREA OF INTEREST

Data is self-reported by students on the admission application. These figures vary from the Common Data Set.



DOMESTIC RACIAL AND ETHNIC DIVERSITY

US Citizens and Permanent Residents, as self-identified on the application. Total exceeds 100% because students may indicate more than one race/ethnicity. Data points differ from the Common Data Set (CDS), where identification of more than one race/ethnicity is reflected in the "more than one race" category and must total 100%. Distinctions within that category are not possible with CDS reporting.

Geographic Information for the Class of 2029






COUNTRIES **REPRESENTED** (BY HOME OR SCHOOL ADDRESS)
